



COVENANT FOR PARTICIPANT TEAMS

We would hereby like to participate in the 2016 TUBITAK Unmanned Aerial Vehicles Competition organised by the Scientific and Technological Research Council of Turkey (TUBITAK) in the wing category as the“..... (name of the institution),” team. We have read and understood the rules at uavturkey.tubitak.gov.tr.

- We accept and pledge that we will abide by all provisions in the Rules for the TUBITAK Fixed-wing Unmanned Aerial Vehicles or Rotary-wing Unmanned Aerial Vehicles Races; we will be able to participate in the race only in accordance with the guidelines in the rules; otherwise, we know that we will be dismissed as a team from the competition by the jury’s decision,
- If we participate in the competition, we will be responsible for taking any safety precautions regarding third parties, our party, team members, service personnel, and the vehicle we will use; TUBITAK or sporting event organisers will not bear any pecuniary and/or nonpecuniary liabilities towards our party or third parties due to any accident, damage, natural disaster, or disability that might take place before or during the race,
- We will abide by all relevant legislation to be issued by TUBITAK and sporting organisers,
- With this contract, we will implement pilot studies to be held separately from the competition as determined by the TUBITAK Unmanned Aerial Vehicles Jury in order to develop the competition,
- If one or several team members are determined to have conducted ungentlemanly behaviour by written or verbal means against other team members or event organisers before or during the race, we will be dismissed from the races by the jury and we may be banned from participating in the competition for at least 1 year,
- We are aware that we will bear pecuniary/nonpecuniary liability for damages incurred by TUBITAK if our status/conduct requires dismissal,
- We are aware that recognition of prizes and/or financial support and expenditures to be provided in the scope of the activity will be realised within the framework of the rules,
- In the event of failure to participate in the activity without a valid excuse or dismissal from the activity due to ungentlemanly conduct, all of the subsidies provided for participating as an institution/organisation or team with this covenant will be returned to the relevant bank account of TUBITAK within fifteen (15) days following the end date of the competition.
